Dear Mr. Browning:

This is in response to your request for an advisory opinion regarding a number of Division of Elections (Division) opinions that may be affected by a recent amendment to the "resign-to-run" law, section 99.012, Florida Statutes. The Division is authorized to provide advisory opinions pursuant to section 106.023(2), Florida Statutes, when requested by any supervisor of elections.

You have expressed concerns about the continuing viability of any opinions that construe the leave of absence requirement for subordinate officers in section 99.012(5)(b), Florida Statutes. House Bill 295 (ch. 00-274, Laws of Fla.) deleted this section, effective June 14, 2000.

In the past, the Division interpreted section 99.012(5)(b), Florida Statutes, to require a subordinate officer who was *not running* against a person with authority to appoint, employ, promote or otherwise supervise the subordinate officer to take an unpaid leave of absence upon qualifying for office, or in the alternative, submit a letter of resignation. See *Op. Div. Elect. 95-03* (May 5, 1995); *Gonzalez v. Vogel*, 616 So. 2d 473 (Fla. 2d DCA 1993). However, with the recent change, subordinate officers may continue to work in their positions without taking an unpaid leave of absence while they are candidates.

Bear in mind that section 99.012(5)(a), Florida Statutes, remains in full force and effect. Accordingly, a subordinate officer must resign to run if he or she is running for a public office that is currently held by an individual who has the authority to appoint, employ, promote or otherwise supervise the subordinate officer. For example, a deputy sheriff must resign, effective upon qualifying, if he or she is running against the incumbent sheriff.

For the above reasons, we hereby rescind the list of attached opinions to the extent that they require subordinate officers who are *not running* against a person with authority to appoint, employ, promote or otherwise supervise the subordinate officer to take an unpaid leave of absence upon qualifying for office, or in the alternative, submit a letter of resignation.

### Summary

The list of attached Division opinions are hereby rescinded to the extent that they require subordinate officers who are *not running* against a person with authority to appoint, employ, promote or otherwise supervise the subordinate officer to take an unpaid leave of absence upon qualifying for office, or in the alternative, submit a letter of resignation.
